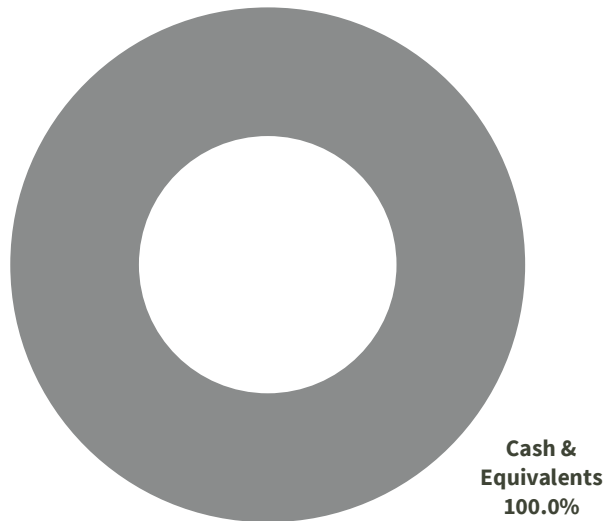


CCF Short Term Pool Quarterly Performance Report – September 30, 2025

Quarterly Commentary / Pool Attribution

U.S. equity markets were positive during the third quarter, along with international equity markets. U.S. equity markets, as measured by the S&P 500 Index, gained 8.1%. Ten of the eleven sectors in the S&P 500 generated positive results, with Consumer Staples (-2.4%) as the lone detractor. The U.S. Dollar appreciated relative to most major currencies during the quarter. Developed Non-U.S. Markets, as measured by the MSCI EAFE Index, gained 4.8% and Emerging Markets, as measured by the MSCI Emerging Markets Index, gained 10.6%.

The Federal Reserve cut interest rates by 25 bps at their September meeting, bringing the policy range to 4.00 – 4.25%.

The 10-year treasury yield ended the quarter at 4.2%, while the 30-year ended at 4.7%.

The Short Term Pool performed in line with its Benchmark during the quarter.
The Pool is made up of cash and cash equivalents securities.
